### ACTION TAKEN REPORT OF REVALUATION

NO REVALUATION FOR ONLINE EXAMINATIONS, APRIL 2020 NOVEMBER 2020 & APRIL 2021 END SEMESTER EXAMINATIONS

Since the outbreak and official declarations of the global pandemic Covid-19 and subsequent nation-wide and state-wide lockdowns from early 2020 onwards, the Examinations Office has had to revise existing guidelines, norms and procedures issued by the higher authorities and common to all the autonomous and affiliated colleges under the University of Madras. During April 2020, November 2020 and April 2021, all semester examinations were conducted via the platforms provided by third party vendors. Answer scripts were evaluated by Internal faculty members instead of External faculty members; however, the question papers were set by External faculty members. Arrear and question papers of Part IV were set by Internal faculty members. Since examinations were conducted remotely, there was no question of Revaluation. However, if students faced any issues in the examination, they were encouraged to bring it to the notice of the authorities and routed through proper channel.

#### **NOVEMBER 2018/APRIL 2019**

The Examinations Office conducts Revaluation soon after the publication of term end examination results. Candidates who wish to apply for Revaluation have to apply within the next ten days. A third External examiner, who had not evaluated earlier is appointed to revalue the scripts. The result of the third examiner is final and binding. In case of any discrepancy in the first round of evaluation, the External or Internal examiner will be debarred from Valuation.

In April 2019 ESE, candidates could apply for photocopy of their answer scripts for Rs. 500/Only students who had taken photocopies of their examination answer scripts were eligible to apply for Revaluation. Candidates were also encouraged to take their answer scripts to their faculty members for checking their scripts to see if the External examiner had awarded appropriate marks. External Examiners were also informed about giving photocopies of answer scripts to those candidates who requested for it.

Single Valuation was introduced for the first UG/PG, 2018 batch. Internal Valuation Monitoring Committee (IVMC) was constituted to check the total marks awarded by the external examiner and in case of any inconsistency or anomaly. For second and third UG and second PG, Double valuation was followed.

During Double Valuation, (mode of Evaluation since the inception of autonomy), if a discrepancy of more than 15 marks is found in the marks awarded by the Internal and the External Examiner, a third examiner is called, (mostly External), to evaluate those answer scripts. The third Examiners' marks are taken as final and binding. The third examiner is invited from the panel of examiners
